City of Palm Springs

Council Members hold 4-year terms Transitioned to Districts in 2019

- Districts 1, 2, & 3 terms begin following election in November 2022
- Districts 4 & 5 terms begin following election in November 2024





Redistricting Process

Step	Description
Initial Pre-Draft Hearings (2)	Held prior to release of draft maps. Education and to solicit input from the community Identify "neighborhoods," "communities of interest," and "secondary areas."
Initial deadline for draft maps	Deadline for the public to submit draft maps for inclusion in the next hearing packet and presentation
Release draft maps	Draft maps posted to project website
Public Hearings (post-map) (2)	Public Hearings to discuss and revise or adopt the draft map(s)
Map adoption	Map adopted via ordinance or resolution. Final map must be posted at least 7 days prior to adoption. May happen at Hearing 4.



Findings

- ➤ Total Deviation is above the 10% "acceptable" range at 12.13%
- ➤ Drawing a majority/minority district *may* not be possible based on the overall percentage of minority residents (Latino's make up 25% of population but are evenly dispersed throughout the community)
- Current district boundaries must be adjusted for population balance





Preeminent Considerations

- Equal population (one person/one vote)
- > Geographically contiguous districts
- > Geographically compact
- Measured objectively





Important Considerations "Communities of Interest"

- Physical boundaries
 - > Natural or artificial barriers
 - > Roadways, rivers, railways
 - > Parks, schools, and other landmarks
- Geographic integrity
- Minority voice





Important Considerations "Communities of Interest"

- Political boundaries
 - School attendance areas
 - Special district service areas
 - > Federal, state, and county divisions





Important Considerations "Communities of Interest"

- > Not:
 - > Incumbents' residences
 - Political affiliations

Timeline & Next Steps

- ➤ The prisoner-adjusted census data was released by the state on September 20, 2021.
- Three additional public hearings must be held before the Council may vote on a proposed final boundary map.
- ➤ The approved map must be submitted to the Riverside County Registrar of Voters no later than April 17, 2022.





Timeline & Next Steps

November 4, 2021	1st public hearing Held prior to the release of draft maps
December 9, 2021	2 nd public hearing Release and consideration of draft maps
December 13-17, 2021	Community Workshops
January 15, 20255	Deadline for the public to submit draft maps for consideration at 3 rd public hearing
January 27, 2022	3 rd public hearing to review publicly submitted maps and consider input from workshops





Timeline & Next Steps

February 10, 2022	4 th public hearing to discuss and select the top (3) maps for further consideration
February 28 – March 4, 2022	Community Workshops in 5 Districts – if necessary
March 14, 2022	5 th public hearing – introduction of Ordinance to approve final maps
April 17, 2022	City deadline to adopt ordinance after 2 nd reading (effective immediately) and to submit map to Registrar of Voters
November 2022	2022 election
