- Districts 4 and 5 term elected in November 2024





### **Redistricting Process**

STEPS	DESCRIPTION
1. Release draft maps	Draft maps posted to project website
2. Public hearing No. 2	Review Draft maps Take public input Consider Communities of Interest
3. Initial deadline for draft maps	Deadline for the public to submit draft maps for inclusion in the next hearing packet and presentation
4. Final public hearing	Public Hearing to discuss and revise, or adopt the draft map(s)
5. Map adoption	<ul> <li>Map adopted via ordinance or resolution</li> <li>Final map must be posted at least 7 days prior to adoption</li> </ul>

- No Racial Gerrymandering




### **California Criteria for Cities**

- Minimize voters shifted to different election years
- Respect voters' choices / continuity in office

## **Findings**

- Total Deviation is above the 10% "acceptable" range at 12.13%
- Current district boundaries must be adjusted for population balance






## **First Review of Draft Maps**

- At this hearing, the public and Council comment will be captured and incorporated into revised maps, if appropriate, and shared during Public Hearing No. 3










## Findings – Map Option A

- Total Deviation is below the acceptable range of 10% at 5.39%
- Preserves the core of existing districts
- Creates more compact voting districts
- Minimizes the number of voters who have to change districts





## Findings – Map Option B

- Total Deviation is below the acceptable range of 10% at 3.23%
- Preserves the core of existing districts
- Creates compact voting districts
- Preserves existing neighborhoods

## Findings – Map Option C

- Total Deviation is below the acceptable range of 10% at 7.90%
- Preserves the core of existing districts
- Closely aligns with the current boundaries.
- Retains District 1 as a combined majority/minority (nonwhite) district
- Minimizes the number of people moving between districts

## Statement of Principles

#### Goals

- Maximize the goals of the (<del>CVRA</del>) Federal Voting Rights Act and FAIR Maps Act, including civil rights, equality, and inclusion.
- Prioritize the creation of minority/majority districts.
- To the extent practical, keep organized neighborhoods intact.
- Maintain the principle that the best interest of the City as a whole remains the first responsibility of all elected officials.

#### Process

- Evaluate our current structure of government and demographics, compare with and learn from other comparable cities and recommend the structure of government that best achieves the goals of the CVRA and the long-term needs of our City.
- Encourage and work through communication platforms to obtain participation from as many residents and stakeholders as possible in the process.
